Privacy Policy

Battlefield Sports

Welcome To Battlefield Sports

Battlefield Sports makes live gaming equipment and markets our goods/services via the Battlefield Sports website (the "site") the business is run by Scapequest Pty Ltd (the "Company" or "we" or "us") for users of the goods and services ("you"). Our sister company Pathfinder Events Pty Ltd runs live games and rents gaming equipment. Brand names include "Laser Tag in a Box" and "Laser Skirmish" and "Battlefield LIVE".

This privacy policy sets out our policy with respect to info that is collected from visitors to the site and users of our goods and/or services. Under the applicable law, Battlefield Sports is the "data controller" of personal data collected by us.

Info We Collect

When you interact with us we may collect info from you, as described below.

Info you provide: We collect info from you when you voluntarily provide it, such as when you register for access to our marketing documents or the Battlefield Sports University. This info may include but not limited to username, email address, images or other content you send via email, online forms or the chat feature.

Other Info

Cookies: We employ cookies and similar tech to keep track of your local computer's settings such as which account you have logged into. Also, we may use tech such as single-pixel gifs, like the facebook pixel, to record log data such as open rates for emails. We may use third party web site analytic tools such as Google Analytics what also employ cookies to collect info concerning your usage. You can disable cookies by changing your web browser settings.

Advertisements: You may see us advertised on other applications or web sites. After clicking on one of these ads, the advertising platforms such as Facebook may collect info for optimizing advertising campaigns.

Data Collected Automatically: When you interact with us we received and store certain info such as an IP address, and which newsletters or documents you have chosen to subscribe to.

Aggregated Info: In an ongoing effort to better understand and serve our users we may conduct research on customer feedback. The research may be compiled and analyzed on an aggregate basis, we may then post research results on our blog. We may also disclose aggregated user statistics in order to describe our services to current and prospective business partners, and/or government agencies, and to other third parties for other lawful purposes.

Where The Info Is Processed

The company is based in Australia. We have agents in the USA and other places. No matter where you are located you consent to the processing and transferring of your info in and to the US and other countries. The laws of Australia and other countries government data collection may not be as comprehensive as the laws of the country where you live.

Our Use of Your Info

We use the info you provide in a manner that is consistent with the policy. If you provide info for a certain reason, we may use that info in connect with that reason. For example, if you contact us by email, we will use the info you

provide to answer your question or resolve your issue. If you provide info to get access to our goods/services we will use your info to provide you with access to such and to monitor your use of such. Kids

Purchasing our goods/services are for users of majority age. We do not knowingly collect personal info from kids. If you are a parent or guardian of a child and believe he or she has disclosed personal info to us please contact us at info@battlefieldsports.com. For citizens of the European Economic Area, where processing of personal info is based on consent, Battlefield Sports will not knowingly engage in that processing for users of minority age as deemed by applicable data protection law. If we learn that we are engaged in that processing we will halt such processing and will take reasonable measure to promptly remove applicable info from our records.

Data Security

Your Data Rights
